Privacy Policy

1. Introduction

Welcome to HappyVisit.info. We are committed to protecting your privacy. This Privacy Policy explains how we collect, use, disclose, and safeguard your information when you visit our website https://www.happyvisit.info, including any other media form, media channel, mobile website, or mobile application related or connected thereto (collectively, the "Site"). 3. Use of Your Information
